As specified under Title 22, Chapter I, Part 51, Subpart B, Section 51.135 of the Supplement to Passport Regulations of the Department of State, I do hereby affirm that:

1. I do not support the world Communist movement of which the Communist party is an integral unit," and , that I have never supported such a movement.
2. I am not now, and have never been a member of the Communist Party.
3. I have not knowingly engaged in any activities because of the "result of direction, domination, or control exercised over me by the Communist movement."
4. I am not going abroad for the purposes of, have never gone abroad for the purposes of, and have never been asked to go abroad for the purposes of "engaging in activities which will advance the Communist movement for the purpose, knowingly and willfully of advancing that movement."

The four passports issued to me since 1932 have been utilized as follows:

- 1932: Europe; purposes of vacation and travel under an Open Roadtour.
- 1938: Caribbean Area; to round out my demographic studies of the West Indies. (Published as The Negro Immigrant, Columbia Uni. Press. NY. 1939).
- 1939: England; To continue demographic studies at the London School of Economics. West Africa; for vacation, research, and to visit friends and acquaintances in Liberia, Gold Coast, and Nigeria. They included the US Minister to Liberia, Lester A. Walton; Deaver P. Young, a Firestone Co, representative in Monrovia; A Caseley-Hayford, then Magistrate, Kofifadua, Gold Coast, now Minister of Agriculture; the Alake of Abeokuta in Nigeria.
- 1948: England and France; Conducting a Ship Orientation Program for Foreign and American students, auspices of the American Friends Service Committee.
- 1949: Switzerland and France; Vacation, and to conduct a west-bound Ship Orientation Program for Youth Argosy.
- 1952: It was planned to attend the World Friends Conference in England as a representative of the American Friends Service Committee, and to visit their work camps in England and France, thereafter. My responsibilities as director of the Foreign Student Orientation Program on the College campus(a program conducted by the Institute of International Education for the Department of State, and on which I have worked two successive summers) did not permit me to leave the cuntry for that period of time. I have been requested to attend the Kingston, Jamaica meetings of the Caribbean Commission during the latter part of this month, as a prelude to the fertility studies of that area which I have been asked to undertake.

This statement is made under the conditions prescribed by law. I affirm that the facts cited herein are true.
