THE WAR HAS BEGUN!!

FORT SUMTER ATTACKED YESTERDAY MORNING!

Bombardment all day yesterday.

THE FIGHT IS BEING REHEARSED THIS MORNING.

By our telegraphic dispatches it will be seen that the ball has been opened and the dance of death has begun. Fort Sumter was attacked yesterday morning at 4 o'clock, by the batteries upon Morris and Sullivan's Islands, and by Fort Moultrie. Our bombardment had telegraphed to the Government at Montgomery for instructions, and was directed to demoralize the garrison of the Fort; if this demand was not complied with then the Fort was to be reduced. Accordingly, the attack was commenced and Major Anderson retained the fire. Further dispatches say that the fire was kept up all day from seven batteries, including the floating battery. Major Anderson's guns had not made any serious breach in the forts and batteries against which he had directed his fire. It was reported that on the other hand, breaches had been opened in the walls of Sumter. All the however, is the Charleston side of the story must be taken with great allowance. The gunnery of the Point battery is the only one that has been considered with any accuracy in the reports. As this is not named among those which had been engaged in the attack, we do not credit the statement that a breach had been effected. We have as yet, no news of the war provisions vessels outside the harbor. The rebels seized the opportunity before the attack of the sea of action. They should avoid, be there by this time, ready to assist the gallant Major in his defence.
